

## **MegaTok - Privacy Policy**

Last Updated: July, 2021

### **1. General**

#### **1.1. Welcome to MegaTok!**

We value the privacy of our Users and are dedicated to protecting it.

1.2. This Privacy Policy provides important information regarding the data and information we collect, receive, use and manage during your Use of the App. Please read this Privacy Policy before accessing or otherwise using the App.

1.3. The Privacy Policy is incorporated into our Terms of Use and is subject thereto. Any terms not defined herein but defined in the Terms of Use shall have the meaning ascribed thereto in the Terms of Use.

**1.4. By accessing and/or viewing and/or visiting and/or browsing the App for any purpose, you are expressing your agreement to this Privacy Policy and provide Your informed, freely consent to the terms herein. If you do not agree to this Privacy Policy, whether in whole or in part, please do not access and/or view and/or visit and/or browse the App for any purpose.**

1.5. Unless stated otherwise, this Privacy Policy applies to all Information that we collect about You and Your Account. Megatok is not responsible for any action of third parties, the content of their sites, their use of Information they collect, or any products or Websites they may offer you. Any link to those sites contained in our Platform does not constitute our sponsorship or affiliation with those third parties.

1.6. We may update this Privacy Policy from time to time in order to comply with applicable privacy laws and to notify you regarding changes in our practices of data collection and use of Information.

### **2. Definitions:**

2.1. **“Data”, “Sensitive Data”** – as defined in the Protection of Privacy Law 5741-1981.

2.2. **“Information”** shall mean Personal Information and Non-Personal Information, together.

2.3. **“Personal Information”** shall mean “Data” and/or “Sensitive Data”, including any

Information, data or content, in any format or media, which can personally identify You as an individual and/or otherwise can be attributed to You as an individual which You knowingly insert and/or otherwise upload to the App in order to create an Account and/or to Use the App.

2.4. **“Non-Personal Information”** shall mean any information, data or content in any format or media, which is anonymous and/or does not personally identify You and/or reveal Your specific identity as an individual, and/or cannot be attributed to You, in whatever form is collected and/or received in as a result of Your Use of the App, including without limitation information about your mobile device and IP address.

### **3. Personal Information**

3.1. **Basic Account Information.** You don't have to create an account to use some of our features. However, if you do choose to create an account, you must provide us with some personal data so that we can provide our services to you, such as your age, your name, a username and your phone number. Your name and username are always public, but We do not require your screen name to be your real name. Note that users who have you in their contacts will see you by the name they saved and not by your screen name.

3.2 **Phone Number and Contacts.** MegaTok uses phone numbers as unique identifiers. We ask your permission before syncing your contacts. You can always change your permissions through your device settings.

### **3.3. Your Information**

3.3.1. **Channels.** Your channel can be accessed by anyone on MegaTok. This means that everything you post in your channel will be accessible to everyone. You are responsible for your posts and other information you provide through our services, and you should think carefully about what you make public, especially if it is sensitive information.

3.3.2. **Chat.** In addition to channels, MegaTok also supports private chats. Your messages in chat are encrypted, which means that they cannot be accessed by third parties. This means that the message is technically on one of our servers, but it looks like a piece of random indecipherable garbage to everyone except for you and the recipient. We don't know what this random data stands for. However, You should also be aware that all of your messages are saved on your own device.

3.3.3. **Third-Party Information.** Information Others Provide About You. We receive information about you from other MegaTok users. For example, when other users you know use our Services, they may provide your phone number and name from their mobile address book,

just as you may provide theirs. They may also send you messages or send messages to groups to which you belong, send photos you appear in, or mention your name.

You should keep in mind that in general any user can capture screenshots of your chats or messages or share your messages and post them on MegaTok or any other platform.

**3.5. User Reports.** Just as you can report other users, other users or third parties may also choose to report to us your interactions and your messages with them or others on our Services; for example, to report possible violations of our Terms or policies.

#### **4. Non-Personal Information**

**4.1. Usage And Log Information.** We collect information about your activity on our Services, like service-related, diagnostic, and performance information. This includes information about your activity (for example: the time, frequency, and duration of your activities), and performance logs and reports. This also includes information such as when you registered to use our Services; whether you are online.

**4.2. Device And Connection Information.** We collect device and connection-specific information when you install, access, or use our Services. This includes information such as hardware model, operating system information, language and time zone, IP address.

**4.3. Cookies.** The only cookies we use are those to operate and provide our website Services. You may choose to block cookies with your web browser.

#### **5. How we use Your Information**

5.1 We use your information to improve, support and administer the platform. We generally use the information we collect :

- To customize the content you see when you use the platform. For example, to show you content based on your language settings or content that is similar to content that you liked or interacted with.
- To improve and develop our platform.
- To support the social function of the platform, including to allow you and other users to connect with each other through the platform.
- To understand how you use the platform.
- To help us detect abuse, fraud and illegal activity on the Platform.
- To communicate with you.
- To enforce our terms, conditions and policies.
- To provide user support.

- For any other purposes disclosed to you at the time we collect your information or pursuant to your consent.

## **6. Who Your Information May Be Shared With**

**6.1. Other MegaTok Users.** Other users of our App with whom you choose to communicate with and share certain information. Note that by entering into the Terms of Service and choosing to communicate with such other users of MegaTok, you are instructing us to transfer your personal data, on your behalf, to those users in accordance with this Privacy Policy. We take reasonable measures to (including encryption of your personal data) to ensure a level of security for your personal data that is appropriate to the risk.

**6.2 Law Enforcement Authorities.** If MegaTok receives a court order that requires us to do so, we may disclose your IP address and phone number to the relevant authorities. So far, this has never happened.

**6.3 With Your Consent.** If you access third-party services such as Google, Facebook or Twitter to login to the platform or to share information about your usage on the platform with others, these third parties may be able to collect information about you.

If you choose to post your content on the Platform, you should be aware that any information you share may be read, collected, or used by other users. We are not responsible for information you choose to submit.

## **7. Retention of information.**

7.1 We may retain Your information for an unlimited period, and at least for as long as Your Account is active. We will also retain and use Your information as necessary to comply with our legal obligations, resolve disputes, and enforce our agreements.

## **8. Spam and Abuse**

8.1 To prevent phishing, spam and other kinds of abuse and violations of megaTok's Terms of Service, our moderators may check messages that were reported to them by their recipients. If a spam report on a message you sent is confirmed by our moderators, your account may be limited or banned - temporarily or permanently. ## **9. Children and MegaTok**

8.1 Our services are not directed to children, and you may not use our services if you are under the age of 13. You must also be old enough to consent to the processing of your personal data in

your country (in some countries we may allow your parent or guardian to do so on your behalf).
